

## GOVERNMENT OF WEST BENGAL OFFICE OF THE DISTRICT MAGISTRATE NORTH 24 PARGANAS, BARASAT (JUDICIAL MUNSHIKHANA DEPARTMENT) ORDER



Whereas Authorized Officer, Indian Bank (E-Allahabad bank) Zonal Office Barasat, 54, K.N.C.Road, Barasat, North 24 Parganas, Kolkata – 700 124 has filed a petition u/s 14 of SARFAESI Act of 2002 seeking administrative assistance for taking physical possession on the secured assets/Property of the Borrower namely Sri Sagar Chandra Biswas S/o. Late Narayan Chandra Biswas, residing at, Vill – Banbania, PO – Habra, PS – Habra, North 24 Parganas, PIN – 743 263. (Case No – 149/23/MN)

and

Whereas in the light of above order the petition along with affidavits and other relevant documents submitted by the Authorised Officer, Indian Bank (E-Allahabad bank) Zonal Office Barasat, 54, K.N.C.Road, Barasat, North 24 Parganas, Kolkata – 700 124, seeking administrative assistance in terms of sec 14(1) of the SARFAESI Act of 2002 for taking over physical possession of the secured asset is/are seen and taken up for consideration

and

Whereas from the documents and status report submitted by the Authorised Officer, it transpires that the secured creditor Granted a loan Rs. 16,00,000.00 (Rupees Sixteen Lac Only) on 26.03.2018 to Borrower namely Sri Sagar Chandra Biswas S/o. Late Narayan Chandra Biswas, residing at, Vill – Banbania, PO – Habra, PS – Habra, North 24 Parganas, PIN – 743 263, against the all the mortgaged piece and parcel of landed property as follows:

SCHEDULE OF PROPERTY

- All that one self contained residential Flat No. C, on the 3<sup>rd</sup> Floor of the multi-storied building namely "Swapna Mandir Apartment" measuring an area more or less 778.50 Sq. Ft. be the same little more or less together with undivided proportionate share of land and the common areas and facilities, landed property measuring an area more or less 06 Cottah 06 Chittacks 05 Square Feet be the same little more or less along with the multi storied building comprised in R.S.Dag No. 332, 247 & 248, L.R.Dag No 685 & 691, under RS Khatian No. 132,, 134 & 223, L.R.Khatian No 439 \* 5298 laying and situated at Mouza Hariharpur, J.L.No 40, Re Su No. 119, Touzi No 146, within the local jurisdiction of Barasat Municipality, Holding No. 5/9/1 Nripan Ghosh Sarani, PO Hridaypur, PS Barasat, Kolkata 700 127. The property is butted and bounded by North 20' wide Municipal Road, South H/o. Nantu Gopal Chakraborty, East Chowdhury Villa & 8 ft. wide common passage, West House of Bimal Mondal and Anima Kar. The Mortgaged Property stands in the name of Sri Sagar Chandra Biswas S/o. Late Narayan Chandra Biswas and being the registered Deed No. I 152503359 for the year 2018 and the deed is registered at the office of DSR III, North 24 Parganas, West Bengal.
- 2) The borrower has committed default in repayment of the financial assistance granted aggregating the specifiedamount and consequent to such default in repayment, the account of borrower was classified as NPA on 11.02.2022 due to non servicing of interest/installment.
- 3) Notice dated 05.05.2022 u/s 13(2) of SARFAESI Act. 2002 demanding payment of default amount was served to the defaulting borrower. The total outstanding amount as mentioned in notice is Rs 17,50,865.00 (Rupees Seventeen Lac Fifty Thousand Eight Hundred and Sixty Five) only and the demand notice was received by the borrower on 11.05.2022, 12.05.2022, 13.05.2022 and 03.06.2022.
- 4) The Authorised Officer of the secured creditor received no representation from the borrower in reply to demand notice u/s 13(2) dated 05.05.2022.
- 5) The Secured creditor issued possession notice dated 02.08.2022 u/s 13(4) of SARFAESI Act of 2002 for taking Possession on the secured assets of the borrower and also published the same in the daily news papers on 05.08.2022 & 07.08.2022
- 6) Thus the Authorised Officer of the secured creditor observed all the formalities as laid down in the SARFAESI Act 2002 for realization of the said outstanding amount from the secured debtor

7) whereas, the Secured Asset in within the jurisdiction of the District Magistrate, North 24- Parganas

- 8) whereas, the amount dues more than 20% of the Principal Advance and Security interest is not created in any agricultural land and
- 9) whereas, the secured creditor wants to reconstruct their financial asset(s) after handing over and taking over physical possession of the secured asset / property as scheduled above, belonging to the Borrower(s) / Co-borrower(s) / Director(s) / Guarantor(s) / Partner(s) / Proprietor(s) / Corporate Guarantor(s) / Surety(ies) as per law in force

10) whereas, for the purpose of taking possession of the secured asset(s) and documents, the secured creditor requested the District Magistrate, North 24 Parganas u/s 14 of SARFAESI Act of 2002.

11) There is no case pending before any court of law under Section 34 of SARFAESI Act, 2002 in this regard filed by the borrower as per '30 Clauses' declaration submitted by the secured creditor and as per affidavit dated 22.08.2023 submitted by the secured creditor there is no stay declared by any court of law

12) The property is not under leesee/tenancy as per affidavit, deed(s), records or all other relevant documents and

Therefore, after careful consideration of the contents of the affidavit including the nine clauses mentioned under Section 14(1)B of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 and all other relevant documents, which the secured creditor filed duly affirmed by the authorized officer of Indian Bank (E-Allahabad Bank) Zonal Office Barasat, 54, K.N.C.Road, Barasat, North 24 Parganas, Kolkata – 700 124, the secured creditor and being satisfied, it is hereby ordered that Sri Rajib Sardar, Executive Magistrate by Sub Section (1) of Section 20 of the Criminial Procedure, 1973 (Act 2 of 1974), in the Office of the District Magistrate, North 24- Parganas, under the District Magistrate North 24 Parganas will take physical possession of the secured assets/property and forward the same to the secured creditors u/s 14 (1A) of SARFAESI act. 2002

The secured creditor will remain present at the time of taking over physical possession

The order is to be enforced within 06 (Six) months from the date of receipt of this order.
