ORDER

Whereas Authorized Officer, Ujjivan Small Finance Bank Limited, Eastern Regional Office, Rishi Tech Park, 4th floor, Premises no 020360, Plot no DH -6/2, Action area ID, New Town, P.O – Rajarhat, P.S- New Town (Old Rajarhat), Kol-700160 has filed a petition to the District Magistrate, North 24-Parganas, u/s 14 of SARFAESI Act of 2002 seeking administrative assistance for taking physical possession on the secured assets/Property of the Borrower & Guarantor namely Sri Sujit Mondal S/O Sri Gobinda Mondal and Smt. Dipu Mondal, W/O- Sri Sujit Mondal both are residing at Dakshin Bhebia ,Near Bhebia Bazar, North 24 Parganas, Pin – 743456. (Case No – 12/24) dated 12.02.24.

whereas in the light of above order the petition along with affidavits and other relevant documents submitted by the Authorised Officer, Ujjivan Small Finance Bank Limited, Eastern Regional Office, Rishi Tech Park, 4th floor, Premises no 02-0360, Plot no DH -6/2, Action area ID, New Town, P.O – Rajarhat, P.S- New Town (Old Rajarhat), Kol-700160 seeking administrative assistance in terms of sec 14(1) of the SARFAESI Act of 2002 for taking over physical possession of the secured asset is/are seen and taken up for consideration

and

whereas from the documents and status report submitted by the Authorised Officer, it transpires that the secured creditor granted a loan Rs. 4,00,000.00 (Rupees Four Lac Only) on 19.10.2019 Only to Borrower & Guarantor namely Sri Sujit Mondal S/O Gobinda Mondal and Smt.Dipu Mondal W/O- Sujit Mondal both are residing at Dakshin Bhebia ,Near Bhebia Bazar, North 24 Parganas, Pin – 743456 against the all the mortgaged piece and parcel of landed property as follows:

SCHEDULE OF PROPERTY

- 1) All that piece and parcel of land measuring about 3 decimals ,situated at Mouza – Sadigachi, P.S- Hasnabad, Pargana- Agarpara, J.L.No – 6, Touzi no- 956, R S Khatian No – 848. L.R khatian nos. – Kri -925/1, 2490, C.S Dag. NO -920 R.S & I.R. Dag NO -1176 under Bhebiya Gram panchayet ,North 24 Parganas. Pin code -743456. Owned by Sri Sujit Mondal (no- 1 among you) by virtue of Bengali gift deed, dated 16.06.2014 and corresponding to 1421 B.S registered.The Mortgaged Property stands in the name of Sri Sujit Mondal, S/O Gobinda Mondal and being the registered Deed No. 02969 for the year 2014 at the Office of the A.D.S.R.- Hasnabad, North 24 Parganas.
- 2) The borrower has committed default in repayment of the financial assistance granted aggregating the specified amount and consequent to such default in repayment, the account of borrower was classified as NPA on 04.01.2021 due to non servicing of interest/ installment
- 3) Notice dated 22.07.2021 u/s 13(2) of SARFAESI Act. 2002 demanding payment of default amount was served to the defaulting borrower. The outstanding amount as mentioned in notice is Rs.4,66,477.23 (Rupees Four Lac sixty six thousand four hundred seventy seven and two three paise) Only. The Demand notice was received by the borrower on 27.07.2021.
- 4) The Authorised Officer of the secured creditor received on representation from the borrowers in reply to demand notice u/s 13(2) on 22.07.2021
- 5) The Secured creditor issued possession notice dated 11.03.2022 u/s 13(4) of SARFAESI Act of 2002 for taking Possession on the secured assets of the borrower and also published the same in the daily news papers on 15.03.2022.
- 6) Thus the Authorised Officer of the secured creditor observed all the formalities as laid down in the SARFAESI Act 2002 for realization of the said outstanding amount from the secured debtor
- and
- 7) whereas, the Secured Asset in within the jurisdiction of the District Magistrate, North 24- Parganas

- 8) whereas, the amount dues more than 20% of the Principal Advance and Security interest is not created in any agricultural land
- And
- 9) whereas, the secured creditor wants to reconstruct their financial asset(s) after handing over and taking over physical possession of the secured asset / property as scheduled above, belonging to the Borrower(s) / Co-borrower(s) / Director(s) / Guarantor(s) / Partner(s) / Proprietor(s) / Corporate Guarantor(s) / Surety(ies) as per law in force
- and
- 10) whereas, for the purpose of taking possession of the secured asset(s) and documents, the secured creditor requested the District Magistrate, North 24 Parganas u/s 14 of SARFAESI Act of 2002.

11) There is no case pending before any court of law under Section 34 of SARFAESI Act, 2002 in this regard filed by the borrower as per '30 Clauses' declaration submitted by the secured creditor and as per affidavits submitted by the secured creditor there is no stay declared by any court of law

12) The property is not under leese/tenancy as per affidavit, deed(s), records or all other relevant documents and

Therefore, after careful consideration of the contents of the affidavit including the nine clauses mentioned under Section 14(1)B of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 and all other relevant documents, which the secured creditor filed duly affirmed by the authorized officer of Ujjivan Small Finance Bank Limited, Eastern Regional Office, Rishi Tech Park, 4th floor, Premises no 020360, Plot no DH -6/2, Action area ID, New Town, P.O – Rajarhat, P.S- New Town (Old Rajarhat), Kol-700160 the secured creditor and being satisfied, it is hereby ordered that Sri Chittajit Basu, Executive Magistrate by Sub Section (1) of Section 20 of the Criminal Procedure, 1973 (Act 2 of 1974), in the Office of the Sub- Divisional Officer, Basirhat, North 24- Parganas, under the District Magistrate, North 24 Parganas will take physical possession of the secured assets/property and forward the same to the secured creditor u/s 14 (1A) of SARFAESI act. 2002

and

Whereas Authorized Officer, of Ujjivan Small Finance Bank Limited, Eastern Regional Office, Rishi Tech Park, 4th floor, Premises no 020360, Plot no DH -6/2, Action area ID, New Town, P.O – Rajarhat, P.S- New Town (Old Rajarhat), Kol-700160 shall intimate the date of possession of the secured asset to the Superintendent of Police, Basirhat P.D, North 24 - Parganas, as well as to, Sri Chittajit Basu Executive Magistrate by Sub Section (1) of Section 20 of the Criminal Procedure, 1973 (Act 2 of 1974), in the Office of the Sub- Divisional Officer, Basirhat, North 24- Parganas, well in advance to take physical possession of the secured assets/Property of the secured creditor on behalf of the District Magistrate, North 24- Parganas, The Superintendent of Police, Basirhat P. D, North 24 - Parganas, will provide police force for maintenance of law & order. The secured creditor will remain present at the time of taking over physical possession.

A spot videography should be made in connection with taking over physical possession of secured assets, on the date of taking over possession and soft copy of the videography should be kept under custody.

The order is to be enforced within 06 (Six) months from the date of receipt of this order.
