

### ORDER

In reference to the Memo No.HFW-43011(18)/3/2020-ADMIN SEC/A 3515, Dated 09/10/2020 no. the candidates of Annexure-A has been selected category wise Medical Technologists (Critical Care) purely contractual posts on purely contractual basis at a monthly remuneration of **Rs. 20,000/- (Rupees twenty thousand consolidated)** only and posted in place as mentioned against their respective names "Place of Posting".

The candidates of Annexure-A are hereby engaged as per the terms and conditions mentioned below:-

- 1). The order of engagement will take effect from the date he/ she joins the position.
- 2). The period of contract will automatically be terminated after a period of one year (from issuance of this order) or till regular recruitment of MTCC (critical care) is made, whichever is earlier.
- 3). If the incumbent proposes to cease his/her work without covering 1 month's notice period, his/her remuneration will be deducted accordingly.
- 4). The service may also be terminated by one month's notice from either side.
- 5). The candidates are directed to report for joining for the position of MTCC to the CMOH North 24 Parganas.
- 6). The candidate should join within 27<sup>th</sup> October 2020.

- 12). The candidates has to prepare Contract paper on Non judicial Stamp paper of Rs. 50/ 100, as per the matter has given in (Annexure C).


