Terms and Conditions for supply of Medicines / Equipments for Pregnant Mother and Neonates etc., for North 24-Parganas Dist. Hospital, Barasat vide Tender Notice BH/11/ No. 177 ,Dt. 19.1.12

1. In case of necessity, the date of opening may be deferred, in that case notification will be displayed in the office Notice Board of the undersigned in due course of time.
2. No tender will be considered if the same is not submitted in the Prescribed Schedule.
3. The name and address of the Tenderor must be mentioned on the Sealed cover.
4. Tenderor or their representative may remain present at the time of opening Tender on the date and time given on the notice.
5. Tenderor has to be submitted quotation/Tender at their own cost to the office which must be sealed and deposited within the schedule date and time as mentioned and said quotation will be opened by the Purchase Committee in presence of the Tenderor or their authorized representative.
6. The claimed rate should cover transport and delivery charges. The Tender must indicate clearly whether the price quoted is inclusive of VAT, Sales Tax or not. The rate should clearly be quoted in writing in respect of the item separately.
7. The undersigned has the right to accept or reject of this process without assigning any reason.
8. All sheets of papers in each cover shall be numbered serially and the number of sheet in each cover shall be cited in the covering tally.
9. Purchase committee has authority not to accept the lowest quotation to avoid unwanted hazards.
10. Xerox copy of PAN No., VAT Registration (if any), Trade License, Drug License and P. Tax Certificate will be furnished in sealed cover of the Tender.
