

EXPRESSION OF INTEREST

An Expression of Interest (EOI) is hereby invited from the reputed NGOs/ CBOs /Trusts etc. for delivery of vaccines through three speed boats which shall be run and maintain by the NGOs/ CBOs /Trusts in the Hingalgunj and Sandeshkhali-II Blocks of North 24 Parganas as per the terms and condition of the bid-documents available in the official website of North 24 Parganas.

The last date of submission of the application of EOI is 12th June 2012 by speed post only. The application format is also available in the official website of North 24 Parganas, i.e., www.north24parganas.gov.in

Eligibility Criteria for participating in the EOI:

The bidder must have the following documents and capacity:

1. Competent enough to deal with the work for running boats turbulent water
2. Previous experience in maintenance of motorized fiberglass boats or similar nature of work experience.
3. Capacity to provide the manpower provided to carry out the scheme
4. Registered under the Society Registration Act-1961 and submitted return regular basis.
5. Not have been blacklisted by any Government Department
6. At least 3 years experience in the similar nature of work

Terms and Condition of the bid-documents:

1. The First Party (Secretary, DH&FWS and Chief Medical Officer of Health, North 24 Parganas) shall hand over (no. of speed boats) speed boats being (particulars of the vehicle, i.e. make, Engine No, chassis No,) as more particularly mentioned and described in the schedule of this Agreement hereunder written and hereinafter referred to as "the said boat" or "the boat" which the Second Party (NGO/CBO/Trust) has duly

received in good running condition inter alias, on the terms and conditions contained in subsequent clauses.

2. The said speed boats shall at all times be owned by the Government of West Bengal represented by the First Party, and at no point of time the Second Party shall deny or dispute the right, title and interest or ownership over and in respect of 'the said boats' of the Government of West Bengal as handed over to the Second Party. The NGOs/CBOs/Trusts etc will not be permitted to undertake any extra fittings in the vehicle without the written approval of the Chief Medical Officer of Health, Barasat, North 24 Parganas of the concerned district

3. The embossing on the body of the Vehicle shall be read as follows "
" The NGOs/CBOs/Trusts etc can display their name as " Run by NGO under the Department of Health & Family Welfare, Government of West Bengal " on other side of the body of the Vehicle.

4. The said boats shall be exclusively utilized by the Second Party for carrying the medicines, vaccines and in emergency, doctors and other health staff and emergency patients from village to the nearest health institution with prior intimation to the Secretary, DH&FWS and CMOH, North 24 arganas

5. For carrying medicines, vaccines and in emergency to carry doctors and other health staff, the Second Party shall be entitled to receive the user charges as follows.

For 1 hr. Boat service:

Kerosene – 15 Liters

Gasoline – 2 Liters

Castrol 2T – 600 ml.

6. Any driver of the speed boat engaged by the Second Party shall move/operate the said boat only after obtaining written instructions for each movement of the boats from the Chief Medical Officer of Health, Barasat, North 24 Parganas or any other employee authorized by him/her in this regard. Such instructions should be recorded in the call record. In addition to the call record, a logbook needs to be maintained by the Second Party and kept with the driver(s) of the boat, indicating therein the distance/time covered for each transportation. The aforesaid Call Record, log book and shall be safely and properly preserved and made available to the Chief Medical Officer of Health, Barasat, North 24 Parganas / The Assistant Chief Medical Officer of Health, Basirhat, North 24 Parganas, BMOH of the two Blocks for verification whenever called for.

7. The Second Party shall engage suitably qualified persons as drivers of the said boats and an assistant driver for each boat for handling and carrying engines and others. These assistant drivers will be responsible for maintaining proper position of the boats in times of tide and web in the river.

Drivers and assistant driver's monthly remunerations will be paid by the first party. Their monthly remunerations are as follows.

Each Driver – ₹ _____/-

Each assistant Driver – ₹ _____/-

Refreshment: ₹ _____ for each staff.

8. The Second Party shall have the obligation to provide the boat services for all working days of the year during the period of this Agreement.

9. The SECOND PARTY will be obliged to provide the boat services to the Office of the Chief Medical Officer Of Health, Barasat, North 24 Parganas, or to its' authorised persons/ organization as and when required during any calamity along the drivers and attendants.

10. The agreement may be terminated by the First party in case


- The Second party is blacklisted by any Government or donor agency;
- The Second party fails to show adequate cause on two consecutive occasions for not complying with the Standard Operating Procedures:
- of non-compliance with statutory requirements;
- of insolvency
- of criminal indictment of any office bearer of the Second Party
- of recurrent misconduct / dereliction of duty by any driver / attendant engaged by the Second Party
- of changing user charges higher than the approved rate;
- The vehicle has been leased out or sub-contracted by the NGO/CBO/Trust etc. to any individual or organization for operation under this scheme.

11. The Office of the Chief Medical Officer Of Health, Barasat, North 24 Parganas, shall monitor the use of the boats to ensure that it is strictly used for emergency transportation only. In the event that it is found that the Second Party is plying the boats for any other purpose, the First Party may terminate this agreement on account of such misuse.

12. In case this agreement is terminated by the First Party on grounds of violation of agreed terms and conditions by the Second Party, the Second party shall be debarred by the Office of the Chief Medical Officer Of Health, Barasat, North 24 Parganas West Bengal from receiving any funds / grant from any scheme or programme run by Government or any institution funded by the Government of West Bengal, for a period of one years from the date of termination of agreement.

13. This agreement shall be initially valid for a period of 1 years from the date of signing, subject to renewal on such terms and conditions and for such a period as may be mutually decided by both the parties, within the overall policy framework of the Government.

14. This Agreement shall be liable to termination upon three-months notice from either side.
