

## CORRIGENDUM NOTICE

Please refer to our tender advertisement available in our district website <http://north24parganas.gov.in> vide No. G-16012/2/2012-GEN/18297 dated 11.06.2012 (published through news papers [Anandabazar & Telegraph] on 13.06.2012). In this connection the following amendment is made.

1. Under QUALIFICATION CRITERIA the SI. No. 6 (in page no 1) should be read as 'Bidder must have executed at least one lease OR rental order in the last 4 years in any Government/PSU/Local Bodies organizations/**Corporate**. The total value of orders must be Rs.25 Lakhs or more (Documentary evidence to be submitted).
2. Under **Evaluation Scoring Guidelines (SI No. 3.12.8)** in page no. 6,
  - a) The line .....*"Similar SI job of at least Rs.25 Lakhs in a single order preferably in Government/PSU as clause no 2 of eligibility criteria"* should be read as ... , **Similar SI jobs of at least Rs.25 Lakhs preferably in Government/PSU/Corporate as clause no 2 of eligibility criteria.**
  - b) The total annual turnover should be read as **Rs.25 Crores** instead of Rs.50 Crore and the evaluation breakup should be read as **5-10, 10-15 & above 15.**
