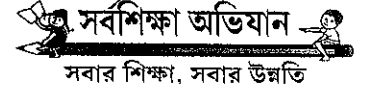

2. The same should be furnished along with tender notice, financial & technical bid form. A demand draft of Rs. 10000.00 (Ten thousand only) in favour of "Sarva Siksha Mission, North 24 Parganas" has also to be submitted as Earnest Money. Offers will be received till 28.9.2012 up to 2.00 pm. The same will be opened on 28.9.2012 at 3.00 pm.
3. The Earnest Money will be refunded back on final completion of the Tender process, only on Proper claim by the quotationer. The Earnest Money will be treated as Security Deposit for the selected quotationer/ quotationers, which will be released at the time of release of Security Deposit. Non submission of Earnest Money will summarily lead to rejection of the Bid. Also, proper documents are to be furnished in case of claiming exemption from the same.

Furthermore the **selected supplier** will be required to submit a Security Deposit of **Rs. 10,000.00 (Rupees Ten Thousand only)** by **Demand Draft** in favour of "Sarva Siksha Mission, North 24 Parganas" immediately on **receiving the Supply Order** from this end, which will be released after completion of the delivery & successful installation and expiry of warranty period.
