Terms & Condition of Auction :

The offer along with the earnest money deposit (EMD) by way of separate Pay Order/Demand Draft for each vehicle separately (See- Table-1) favouring the District Magistrate payable at Barasat should be submitted in plain application mentioning in details Name, Address of the intending bidder along with Demand Draft No. & Date in a sealed covered superscribed : **Offer for purchase of condemned vehicles**" so as to reach the office of the Addl. District Magistrate (G), Barasat, North 24 Parganas on and before 22/02/2013 by 03.00 P.M.

1. The intending bidder may contact Regional Transport Office, North 24 Parganas, Barasat during the office hours on 14/02/2013 for inspection of vehicles.
2. The above vehicles shall be sold on 'AS IS WHERE BASIS', 'AS IS WHAT IS BASIS' AND 'WHATEVER THERE IS BASIS'
3. The above said vehicle(s) shall not be sold below the reserve price mentioned above.
4. The said earnest money deposit shall be adjusted in the case of successful bidder. Otherwise will be returned on the date of opening of the auction itself. The EMD will not carry any interest.
5. **Offers so received by the undersigned will be opened and considered on 23/02/2013 at Motor Vehicles Department, North 24 Parganas, Barasat at 11.00 AM.** The interested bidder or their authorized representative may remain present at the time of such opening and consideration of the bid.
6. The offers without earnest money will be summarily rejected.
7. The successful bidder shall deposit 100 % (adjusting the EMD) of the highest bid price to the Authorized Officer by the way of Cash/Demand Draft/Pay Order favouring District Magistrate, North 24 Parganas, Barasat immediately on acceptance of the offer by the Authorized Officer in respect of sale, failing which amount deposited towards the earnest money shall be forfeited by the Authorized Officer without any notice. The vehicle(s) shall be forthwith be sold again and defaulting purchaser shall forfeit all claim to the vehicle(s).
8. The Authorized Officer is not bound to accept the highest offer or any or all offers and reserves the right to accept or reject any or all offers without assigning any reason thereof.
9. The successful bidder shall bear exclusively all the charges payable including 12.5% sales tax.
10. The sale is subject to confirmation by the Authority.
11. The successful bidder shall lift the vehicle(s) within seven days from the date of sale.
