Tender in sealed cover is hereby invited from Reputed/ Bonafied/ Reliable suppliers for hiring of good number of (1) "Digital Camera" (11) "Video Camera" to be used for ensuing Lok Sabha General Election -2014.

Intending suppliers will quote the daily, weekly and monthly hiring / rental charge of Digital Camera & Video Camera with operator (Cameraman / Videographer), who will report to different sub-divisional head quarter (Barasat/Barrackpore/ Bongaon/ Basirhat/ Bidhan Nagar.).

Digital Cameras should be with at least 6 megapixels with zoom facilities and video cameras should have the feature of real time capturing and time embedded with the video.

Video Cameras will be deployed for video recording of nomination process, assisting expenditure monitoring team, VVT/VST for observance of model code of conduct and some Video cameras will be tagged to Observers. Requirement of Video cameras may be in the tune of 500 (five hundred).

Digital cameras will be deployed for above purposes including deployment at Polling Stations also during elections.

Tenderer will have to submit the tender application with earnest money of Rs 10,000/ (Rupees ten thousand) only in form of demand draft drawn in favour of the Project Director, DRDC, North 24 Parganas, and drop in the Drop Box kept in the DRDC Office (2nd. Floor of ANGANA Building, Barasat, near North 24 Parganas Zilla Parishad building) with in 08/03/2014 between 11.00 am to 4.00 pm. on office day.
