North 24 Parganas; invites open tender in the prescribed form from experienced, bonafied and financially solvent person/persons for appointment of Handling Contractors by the District Controller (Food & supplies), North 24 Parganas for loading & unloading of food grains bag from/into Trucks etc, Stacking food grains bags bagging, re-bagging, weightment, Standardisation , cleaning of food grain, periodical physical verification etc. at the State Govt. Food storage godowns and hired godowns in this district FSD Basirhat, FSD Bongaon, Matia H/G, P G Hi-tech H/G, Kawkepara – III H/G, Lokenath H/G & Pratapnagar H/G for KMS 2015-2016, with provision for subsequent extension of further 6(six) months with the same terms and conditions in two phases of 3(three) months each, if so considered necessary by the employer.

The selected tender along with earnest money of Rs. 5000/-(Rupees five thousand) only in the form of Demand Draft/D.C.R drawn in favour of District Controller, food & Supplies, north 24 parganas, Barasat payable at the State Bank of India, will be received on 16.10.2015 TO 04.11.2015 up to 12 noon in the selected tender box in the chamber of the undersigned.

Any individuals/partner/partners of a partnership firm, Director/Directors of private limited company etc. holding a license under Food and Supplies department as MR dealer/MR distributor or dealing in BPL /AAY wheat for conversion into whole wheat atta by execution of agreement shall not be eligible to be appointed as Handling cum Transport Contractors. Also, the Rice Millers as well as the owners of any private godowns will also be ineligible for being appointed as Handling cum Transport Contractors at the State Govt. owned /Hired godowns.

The selected Handling Contractors shall also have to perform the jobs of preservation and Quality Control Management of stored stocks of food grains in the respective godowns as and when they will be instructed to do so under the supervision and guidance of the Quality Control Trained Inspectorate staff as per Guideline issued by the Director of D.D.P&S, Food & Supplies Department Vide no. 510(18)/FP/IL-09/2015 dated 18.09.2015 in addition to their existing assigned works.

Tender form not accompanied by the earnest money shall be summarily rejected without assigning any reason thereof.

In the tender, the rate is to be quoted clearly at per/below 390% ASOR in terms of percentages where applicable rates quoted above 390% ASOR, will be liable to be rejected.

Sealed Tender along with the Trade licence, income Tax clearance certificate, experience certificate if any should be submitted in the cover with mentioning the name of the godown for which tender is submitted.
