CORRIGENDUM TENDER INVITING NOTICE

In partial modification of the earlier NIT (Tender Inviting Notice) bearing no. 229(9)/MV/Bst. dated 18-01-2016, sealed Tenders / Quotations in prescribed format are invited from intending bidders / agencies for purchasing of vehicles (condemned Seized Vehicles / Government Vehicles) to be sold in auction in terms of Section 12 (6) of W.B. Addl. Tax & One Time Tax on M.V. Act, 1989 & 16 (7) of W.B.M.V. Tax Act, 1979.

The tenderers shall quote his/her rate in the printed letter head pad of his/her agency/firm and submit the same at the SDO Office, Barrackpore or Office of the RTO, Barasat, North 24 Parganas within 03-02-2016 (i.e., last date of submission of tender) up to 02:00 PM which will be opened on 04-02-2016 at 11:30 AM. in the Chamber of the Additional District Magistrate (General), North 24 Parganas.

Other items and information of earlier memo as stated above will remain unchanged.

TERMS AND CONDITIONS

- 1) Bogus/Ambiguous Tenders not conforming to the above shall be summarily rejected without comparison.
- 2) The District Magistrate, North 24 Parganas reserves all the rights not to accept the highest rate or any other rate quoted without assigning the reason. The District Magistrate, North 24 Parganas also reserve the right to cancel the process of tender at any point of time.
- 3) Rate should be quoted in figure and words.
- 4) Collect the tender form @ Rs. 100/- from Nazareth Section of District Magistrate, North 24 Parganas/Sub-Divisional Office, Barrackpore by depositing said money through DCR in Cash Section and submit the Xerox copy of DCR with the tender form, otherwise the tender form will be treated as cancelled.
- 5) Cheque/DD for Earnest money shall be issued in favour of the "**District Magistrate, North 24 Parganas**".
- 6) Earnest money will be returned to the unsuccessful bidder within 15 days.
- 7) The successful bidder/bidders shall deposit the full and final quoted amount made by him/her within 15 days after getting acceptance letter from this end otherwise the deposited amount will be forfeited.
