Terms and conditions:-



2. Tenderers who have credential certificate of single contract for Rs.15,000/- (Fifteen thousand) only for conducting the same nature of work may only quote rate along with valid ST/VAT, PAN, PTC, Credential Certificate, Fire License Certificate.
3. Actual requirement will be mentioned in the work order.
4. No carrying /Loading /unloading Charges will be paid extra.

15. The undersigned has right to accept and or reject the rates so offered without showing any cause. The undersigned is not bound to accept the lowest rates offered.


