The Tenderers/Quotationers shall quote his/her rate in the printed latter head pad of his/her agency/firm and submit the same addressing to the Chairperson, Regional Transport Authority, North 24 Parganas within 30-11-2016 (i.e., last date of submission of tender) up to 02:00 P.M. which will be opened on 30-11-2016 at 03:00 P.M. in the Chamber of the Secretary, Regional Transport Authority, North 24 Parganas, Barasat.

TERMS AND CONDITIONS

- 1) Rate should be quoted in figure and words.
- 2) All bidders shall submit his/her valid certificate of Trade License of similar trade, IT Clearance Certificate for the F.Y. 2015-2016, PAN Card, Voters EPIC, valid Credential Certificate and Address Proof etc. along with his/her application.
- 3) Payment of Electricity Bill should be made by the Lessee on regular basis.
- 4) Lease amount will increase @ of 5% after every 2(two) years.
- 5) Pay and Use Toilet will remain open from 9.00 A.M. to 6.30 P.M. on every working day.
- 6) Rates to be charged from the users as may be fixed by the authority.
- 7) Toilet building will be used for displaying of advertisement by any third party.
- 8) Repairing and renovation of the building shall be made by the lessee.
- 9) Replacement of the tap(cock), basin, mirror, any type of pan shall be made, if found broken/ missing on an emergent basis.
