5. The quotationers clearly maintained on the sealed envelope "Quotation for Operation of Ambulance".
6. The Quotationers should furnish the earnest money amounting to Rs. 1000/- (Rupees one Thousand) only along with tender in the form of Bank Draft/N.S.C./K.V.P./ T.R.Challan duly pledged in favour of the Superintendent, Basirhat Subsidiary Correctional Home.
