

**TERMS & CONDITIONS FOR PARTICIPATION IN THE SEALED TENDER ON 05-08-2019 REGARDING  
DISPOSAL OF THIRTEEN NOS CONDEMNED VEHICLES & TWENTY ONE NOS TWO WHEELER,  
NORTH 24 PARGANAS DISTRICT. VIDE G.O. No.H/TDE/103/V-19/2006 DATED 05-02-2018**

1. Tender form along with terms and condition may be obtained from the office of the undersigned by producing the necessary documents as mentioned in Para-8. Tender form should be submitted in original, (Xerox copy will not be entertained)
2. Condemned vehicles will be sold as it where is basis. All the 13 (Thirteen) vehicles & 21 (Twenty one) Two Wheeler would be sold in a lot & accordingly tenderer would offer their rates for all the vehicles & Two Wheelers in a lot.
3. Intending tenderer will have to deposit earnest money as mentioned bellow against each vehicles and the earnest money is to be deposited to the Head of account **"8443-Civil Deposits-00-103-Secirotu Deposits-001-Earnest/Security Money-07-deposits"**. Banker's cheque, Demand draft in favour of the Chief Medical Officer of Health, North 24 Parganas in original should be enclosed with tender; otherwise the tender will not be entertained. The earnest money will be returned to the unsuccessful bidders in due course.
4. The condemned vehicles may be inspected by the intending tenderer between 12.00 noon to 4.00 PM on & from 29<sup>th</sup> to 31<sup>st</sup> July 2019.
5. The tender should be addressed and sent to the Chief Medical Officer of Health, North 24 Parganas in a sealed envelop super scribed with the words "Tender for disposal of Condemned vehicles of Non FW program (North 24 Parganas District)".
6. The tenders in sealed cover will be accepted up to 12 noon on 05-08-2019 in the office chamber of the CMOH, North 24 Parganas, and the same will be opened on 05-08-2019 at 2 PM in the office chamber of the undersigned when tenderer may depute their representatives to witness opening, if desired.
7. Rate will be quoted separately for each vehicle. In case of none attaining the reserve price and or otherwise the authority reserves the right to reject or cancel any tender without assigning any reason whatsoever.
8. This terms and conditions be issued to the intending tenderer on production of valid & current Trade License, GST registration updated challan (of last quarter), PT Registration with updated challan, IT Return of AY 2015-16,2016-17,& 2017-18. clearance certificate with PAN card Xerox copy with attested must be enclosed along with the tender without which the tender not be accepted.
9. Successful tenderer should be lift the condemned vehicles after payment of quoted and accepted amount in full is to be deposited to the head of A/c. **"0210-Medical & PH-01-Urban Health Services-800-015-27-Other Receipts"** in State Budget within 10 days from the date of receipt of intimation about acceptance of rates from the office of the undersigned under their own arrangement failing which the deposited earnest money is liable to be forfeited and acceptance of offer also to be treated as cancelled.
10. In case of applicability of GST at any stage the same is to be paid by the Tenderer and rates offered should include that amount. In no cases GST amount will be deducted from the offered amount.
