## 2. Payment procedure:

### a) Payment by Net Banking (any enlisted bank) through ICICI Bank Payment Gateway

i.) On selection of net banking as the payment mode, the bidder will be directed to ICICI Bank Payment Gateway webpage (along with a string containing a Unique ID) where he will select the Bank through which he wants to do the transaction.

ii.) Bidder will make the payment after entering his Unique ID and password of the bank to process the transaction.

iii.) Bidder will receive a confirmation message regarding success/failure of the transaction.

iv.) If the transaction is successful, the amount paid by the bidder will get credited in the respective Pooling account of the State Government/PSU/Autonomous Body/Local Body/P, R.Is, etc maintained with the Focal Point Branch of ICICI Bank at R.N.Mukherjee Road, Kolkata for collection of EMD/Tender Fees.

### b) Payment through RTGS/NEFT

iii) Once payment is made, the bidder will come back to the e-procurement portal after expiry of a reasonable time to enable the NEFT/RTGS process to complete, in order to verify the payment made and continue the bidding process.

## 3. Refund/ Settlement Process.

i) After opening of the bids and technical evaluation of the same by the tender inviting authority through electronic processing in the e-payment portal of the State Government, the tender inviting committee will declare the status of the bids as successful or unsuccessful which will be made available, along with the details of unsuccessful bidders, to the ICICI Bank by the e-procurement portal through web services.

ii) On receipt of the information from the e procurement portal, the bank will refund, through an automated process, the EMD of the bidders disqualified at the technical evaluation to the respective bidders' bank account from which they made payment transaction. Such refund will take place within T+2 bank working days where T will mean the date on which information on rejection of bid is uploaded to the e procurement portal by the tender inviting authority.

iii) Once the financial bid evaluation is electronically processed in the e- procurement portal, EMD of the technically qualified bidders other than that of L1 and L2 bidders will be refunded, through an automated process, to the respective bidder's bank account from which they made the payment transaction. Such refund will take place within T+2 bank working days where T will mean the date on which information on rejection of bid is uploaded to the e procurement portal by the tender inviting authority. However, L2 bidder should not be rejected till the LOI process is successful.

iv) If the L1 bidder accept the LOI and the same is processed electronically in the e- procurement portal, EMD of the L2 bidder will be refunded through an automated process, to his bank account from which he made the payment transaction. ### **Performance Security**



1. Within 15 (fifteen) days from the date of issue of notification of award by the purchaser, the contractor shall furnish performance security to the health facility for an amount equal to 3% of tendered value. The performance security shall be retained up to 6 (six) months after the date of completion of all contractual obligations by the contractor.
2. The performance security shall be deposited in Indian Rupees to the state government through TR Challan under budgetary head of account 8443-00-103-Earnest Money-01-07-Deposits. No other forms of deposit can /will be entertained by authority.

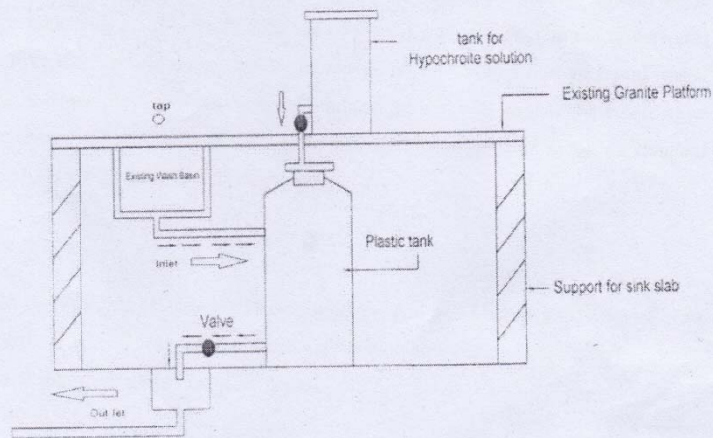
**1. Specification of service**

**Installation of liquid waste treatment miniature in 60 number of UPHCs under North 24 parganas including all material & labour charges**

Amongst all the category of BMW, liquid wastes pose a serious threat to human health and the environment because of their ability to enter watersheds, and thereby pollute ground water, and drinking water when improperly handled and disposed. At the same time, illegal and unethical reuse of this untreated waste can be extremely dangerous and even fatal in causing diseases in epidemic or endemic form.

The discharged waste water from healthcare facilities contains organic or inorganic solids and microbial contaminants which can be measured by the BOD and COD tests. The BOD test measures the oxygen demand of biodegradable pollutants whereas the COD test measures the oxygen demand of the oxidizable pollutants.

ETP or Effluent Treatment Plant is the best way to purify the hospital waste water, but in absence of ETP this infected waste water can be disinfected by making a miniature model for pretreatment using Sodium hypochlorite solution in the Hospitals.





**INLET:**

- (i) The waste water or any liquid waste when poured in the existing wash basin, it is ultimately collected & stored in a plastic tank (minimum 10 lit), situated at the bottom of the Wash Basin through a connector pipe.
- (ii) The connector pipe should be attached with the upper lateral side or side of the plastic tank, so that the liquid waste can be collected. It is preferable that the connector pipe from wash basin to the plastic storage tank should make a downwards angle for free flowing of the liquid waste material.
- (iii) The upper part of the plastic storage tank should connect with a tank (minimum of 5 liter) full of 1% Sodium hypochlorite (NaOCl) solution.
- (iv) A valve must be present in between the tank containing Sodium hypochlorite at the above and Storage tank for liquid waste situated below. The function of the valve plays an important role where if it acts as a regulator to put concentrated Sodium hypochlorite solution in the Storage tank so that the liquid waste can come to contact with the hypochlorite solution.

**OUTLET:**

For the removal of the liquid waste mixed with Sodium hypochlorite solution from the plastic storage tank, another connector pipe should be placed at the bottom of the storage tank with a valve. Here also the connector pipe should make a downwards angle from the Plastic storage tank to the soaked pit for the free flow of liquid waste. Again the valve plays an important role and acts as a barrier so that the liquid waste can be mixed with the concentrated Sodium hypochlorite solution as per its standard contact time for the purpose of disinfection.

**PROCEDURE:**

- (i) Sodium hypochlorite (NaOCl) is a compound that can be effectively used for effluent treatment. It is effective against bacteria, viruses and fungi. Sodium hypochlorite disinfects the same way as chlorine does.

- (ii) It is used on a large scale for surface purification, bleaching, odor removal and water disinfection. Sodium hypochlorite is a clear, slightly yellowish solution with a characteristic odor.
- (iii) Due to the presence of NaOH in sodium hypo chlorite, the pH of the water is increased.
- (iv) When sodium hypo chlorite dissolves in water, two substances form, which play a role in for oxidation and disinfection. These are hypochlorous acid (HOCl) and the less active hypochlorite ion (OCl<sup>-</sup>). By adding hypochlorite to water, hypochlorous acid (HOCl) is formed: $NaOCl + H_2O \rightarrow HOCl + NaOH$  Hypochlorous acid is divided into hydrochloric acid (HCl) and oxygen (O). The oxygen atom is a very strong oxidiser, and due to the presence of active chlorine the disinfection takes place after reaching a contact time of 30 minutes.

#### OUTCOME :

So now when the liquid waste poured in the wash basin, collected at the storage tank & mixed with the 1% concentrated Sodium hypochlorite solution for 30 minutes, its disinfection takes place & BOD & COD of the waste water gets significantly improved. Now this partially treated liquid waste can be disposed off in the environment through the outlet connector pipe into the soaked pit.
