
- a. Date for submitting application for Issuing tender documents & Original Documents verifications :- 07.04.2022(Up to 05.00 pm)
- b. Date for uploading the name of eligible Agencies along with Tender documents in the District Website:- 11.04.2022
- c. Date & time of dropping Tender documents :- 13.04.2022(Up to 2.00 pm).
- d. Date & time of opening tender documents :- 13.04.2022(At 3.00 pm).

The following particulars/papers in Original & also self attested Photostat copies of the same are to be submitted to this Office along with the application in the above noted date & time for issuance of Tender documents failing which no tender paper will be issued . Original papers will be released after checking the same .

- 1.GST Certificate
- 2.Pan Card
- 3.Income Tax Return for last 3 financial years
- 4.Credential Certificate (payment Certificate) of same type of work, i.e. Sinking of Tube well Only & must not be more than 5(five) years from the date of issue of this notice.
- 5.Valid up to date professional Tax clearance certificate
- 6.Audit Report for the last financial year along with the name of the Committee with their specimen signature (in case of Engineering Co-Operative Society/Labour Co-Op. Society).
- 7.Partnership Deed and other relevant papers (in case of Registered Farm/Company)
- 8.Trade license

- A. Application will not be entertained if anybody apply in favour of the party concern. Tender paper will be issued only to the party concerns. The Contractor who has not yet completed the entrusted work of this Office will not issued any tender paper subject to satisfactory report from J.E. concern.
- B. Each Agency should not be participate in this Tender for not more than 2 (two) nos works, otherwise the application will be rejected.
- C. The amount of earnest money as shown in the above table should be deposited in terms of Bank Draft in favour of "P.O-cum-D.W.O, B.C.W, North 24 Parganas " payable at " Barasat" should be submitted along with Tender Documents. Name and Job No. of work should be written clearly on the cover of the sealed Tender Documents for each work. Incomplete Tender(s) are to be rejected summarily.
- D. Time allowed (as per table) for completion of the work shall be deemed to be the essence of the Contract on the part of the Contractor.
- E. Agency will supply all materials at his own cost.
- F. All machineries will be arranged by the agency at his own cost.
- G. Cement will be OPC - 33 Grade, Steel- TATA/SAIL, Pipe-ASTMD 1785
- H. All the conditions as laid down in the Special terms and conditions will be binding upon the tenders and no conditional tenders will be considered for acceptance under any circumstances. This notice and schedule of work shall form a part of this contract in addition to the special terms and condition.
- I. Acceptance of the lowest of any tender will not be obligatory. The undersigned reserves the right to reject any or all the tenders without assigning any reason.
- J. Credential Certificate must not be more than 5(five) years from the date of issue of this notice.
- K. Any eligible Tenderer fails to drop Tender paper will not be eligible to participate in next 2(two) Tender invited by this office.
- L. Any rate 5% above of the schedule rate of work will not be ordinarily entertained.
- M. Before admission of the tender the contractor must visit the work site to judge the local condition from all corners and no plea / complain about the site will be entertained afterwards. It will be presumed that the agency offered the tender after reviewing entire position of the worksite.
- N. Before submitting fill up tender form, the tenderer must be signed in all tender documents papers (Tender Form & Schedule of rates) & must get his signature attested on the contract form by witness failing which his tender may be liable to be rejected.
- O. Claim for idle labour from contractor will not be entertained under any circumstances, no claim will be entertained for any increase in Railway freight and market price.

- P. Arbitration for any dispute on the work will not be entertained as per rule 90 in part IV of PWD rules 1987.
- Q. After scrutiny of applications & other documents, name of eligible agencies are to be uploaded in District Website (www.north24parganas.gov.in) & display in Office Notice Board.
- R. Eligible agencies are requested to download Tender documents (Tender Paper & Schedule of rates) from the District Website.
- S. Fill-up & signed downloaded Tender documents along with original Earnest money to be dropped in separate sealed cover for each work in schedule date & time to the Office of the undersigned, otherwise it will be rejected.
- T. Bill claim by contractor for falls boring will not be entertained under any circumstances.
- U. Water testing report & marked photographs of work should be submitted at the time of claim of Bill. No extra claim of Bill will be made for this purpose.
- V. Supply, fitting & fixing of Display board by writing details particulars of the scheme to be done by the agency at their own cost.
- W. Security period is 12 months after the completion of work.


