1. Eligibility criteria for participation in the tender quotation :

- ❖ All the offers should be properly legible.
- ❖ All the over writing/errors/interpolation must be attested/authenticated by proprietor of the firm.
- ❖ At least three years' experience document for construction / petty repairs works is to be enclosed.
- ❖ Quotation rate should be submitted as prescribed format for Petty repair of two no's toilet block (Painting work) at Police Line under Barrackpore Police Commissionerate.
- ❖ The successfully bidders shall submit Bank Draft @ 10% of Estimate Cost of Petty repair works in favour the Commissioner of Police, Barrackpore as Earnest Money (2%) and Security Deposit (8%).
- ❖ Photo copy of Voter ID Card, Pan Card, Aadhaar Card and valid Trade License should be enclosed with dully attested & seal.
- ❖ Photo copy of valid I. Tax, P. Tax & GST Registration No., Credential Certificate and related papers with dully attested & seal.
- ❖ Separately sealed quotation is addressed to Dy. Commissioner of Police (HQ), Barrackpore Police Commissionerate and to drop in particular tender box within 07 (seven) days at the office of the Commissioner of Police from the date of publication of this Quotation Notice.
- ❖ The successful tenders will have to implement the Petty repair works of the accepted rates within 10 (ten) days from the date of issued of work order.
- ❖ The partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum of Association.
- ❖ The Contractor shall not sublet any portion of the work. If it is found that the contractor has sublet the whole or any part of the work the contract will be cancelled and the EMD of the contractor will be forfeited.
- ❖ Agencies shall have to arrange land for erection of Plant & Machineries, storing of materials, labour shed, Laboratory etc. at their own cost and responsibility.
- ❖ All materials including bitumen (of all grade), bitumen emulsion, cement, Reinforcement etc. shall be of reputed brand as approved by the Engineer-in-Charge in accordance with relevant code of practice and manufacture accordingly and shall be procured and supplied by the agency at their own cost. Authenticated evidence for purchase of bitumen, bitumen emulsion, cement, reinforcement should be submitted along with challan and test certificate if required by this office. If required by the Engineer- in-Charge, further testing from any Government approved Testing laboratory shall have to be conducted by the agency at their own cost. CLU, R.I.
