

6. Partnership Deed and other relevant papers (in case of Registered Firm/Company).
7. Minimum Credential required as noted in the table.
8. Trade license.

1. Application will not be entertained if any body apply in favour of the party concern and tender paper will be issued only to the party concerns. The Contractor who has not yet completed the entrusted work in this Office will not issued any tender paper subject to satisfactory report from J.E. concern.
2. The amount of earnest money as shown in the table should be deposited in terms of Bank Draft in favour of "P.O-cum-D.W.O, B.C.W, North 24 Parganas " payable at " Barasat" should be submitted alongwith Tender Documents. Name and Job No. of work should be written clearly on the cover of the sealed Tender Documents. Incomplete Tender(s) are to be rejected summarily.
3. Time allowed (as per table) for completion of the work shall be deemed to be the essence of the Contract on the part of the Contractor.
4. Agency will supply all materials at his own cost.
5. All machineries will be arranged by the agency at his own cost.
6. Cement will be OPC - 33 Grade, Steel- TATA/SAI, Pipe-ISI mark
7. All the conditions as laid down in the Special terms and conditions will be binding upon the tenders and no conditional tenders will be considered for acceptance under any circumstances. This notice and schedule of work shall form a part of this contract in addition to the special terms and condition.
8. Acceptance of the lowest of any tender will not be obligatory. The undersigned reserves the right to reject any or all the tenders without assigning any reason.
9. Credential Certificate must not be more than 5(Five) years from the date of issue of this notice.
10. Any Tenderer fails to drop Tender paper will not be eligible to participate in next 2(two) Tender invited by this office.
11. Any rate 5% above of the schedule rate of work will not be ordinarily entertained.
12. Before admission of the tender the contractor must visit the work site to judge the local condition from all corners and no plea / complain about the site will be entertained afterwards. It will be presumed that the agency offered the tender after reviewing entire position of the worksite.
13. Before submitting tender the tenderer must be signed in all tender documents papers & must get his signature attested on the contract form by witness failing which his tender may be liable to be rejected.
14. Claim for idle labour from contractor will not be entertained under any circumstances, no claim will be entertained for any increase in Railway freight and market price.
15. Arbitration for any dispute on the work will not be entertained as per rule 90 in part IV of PWD rules 1987.



Special Terms and Conditions :

- a. All works are to be done as per general specification of PWD SOR.
- b. The Contractor shall have no authority to assign the entrusted work to any Sub Contractor for execution of the entire work or any portion thereof.
- c. The Contractor may, however, appointment his site Representative in respect of following purpose only:
- i) General day to day work supervision ;
 - ii) for taking of measurement in field any to sign the records of such measurement.
 - iii) For work related to supply, loading & unloading, stacking etc. at work site.
- d. The Contractor should have to furnish necessary valid clearance certificates for GST and Professional Tax by the appropriate authority, along with the application for issuance of Tender Form; without which no Tender form will be issued from this end.
- e. In case of Engineer's Co-operative Society, up to date audit Report from the appropriate authority must have to be submitted along with the Application.
- f. Tender should be offered in terms of Item Rate Contract.
- g. The tenderers / Contractors should note that no claim for compensation on loss or losses that it may be sustained by them due to reasons beyond control of the undersigned,
will not be entertained and no such compensation for loss or losses will be payable.
- h. The undersigned will be sole judge as to whether the work has been satisfactorily completed or not.
- i. Arbitration for any dispute on the work will not be entertained as per rule 90 in part IV of PWD rules 1987.
