CONDITION OF CONTRACT

1. **Work to be executed in accordance with specification, Drawings, Designs and in terms of Rule of WBF-2911(i)**

The Contractor shall execute the whole and every part of the work in most substantial and workman like manner and both as regards materials and otherwise in every respect in strict accordance with the specifications, the contractor shall also confirm exactly fully and faithfully to the design, drawings and instructions written relating to the work signed by the P.O. cum D.W.O., B.C.W. & TD, North 24 Parganas and lodged in his office and to which the contractor shall be entitled to have access at such office or on the site of work for the purpose of inspection during office hours, and the contractor shall if he so required be entitled at his own expense to made or cause to be made copies of the specifications and of all such design, drawings and instructions as aforesaid.

2. **Compensation for delay**

The time allowed for carrying out the work as entered in the tender shall be strictly observed by the contractor and shall be reckoned from the date on which the order to commence work is given to the contract. The work shall throughout the stipulated period of the contract be proceeded with all due diligence and the contractor shall pay as compensation an amount equal to the percent or such smaller amount as the P.O. cum D.W.O.,BCW & TD, North 24 Parganas may decide on the amount of the tendered amount of the work as shown by the tender for every day that the work remains uncompleted or unfinished after the proper dates provided all ways that the entire amount of compensation to be paid under the provision of this clause shall not exceed the percent on the tendered amount of the work as shown in the tender. The contractor shall commence execution of such part of the work as notified to him diligently continue such work and to ensure good progress during the execution of the work.

3. **Alteration in specifications and Design, do not invalidate contractor**

The P.O. cum D.W.O., BCW & TD, North 24 Parganas have to make any alterations in omissions or additions to or substitutions for the Original Specifications, drawing, design and instructions that may appear to him to be necessary or advisory out the work in accordance with any instructions which may be given to him in written and signed by the P.O. cum D.W.O.,BCW & TD, North 24 Parganas and such alterations, omissions, additions or substitutions shall not invalidate the contractor and any alternates, addition or substituted work which the contractor may be directed to do in the manner above specified as part of the work shall be carried out by the contractor on the same condition in all respects on which he agreed to do the main work and at the same rate as per specified in the tender for the main work.

4. **Action and compensation Payable in case of bad work**

If it shall appear to the P.O. cum D.W.O.,BCW & TD, North 24 Parganas or his subordinate in charge of the work, that any work has been executed with unsound, imperfect or unskilful workman-ship or with any inferior description or articles provided by him for the execution of the work are unsound or a quality inferior to that contracted for or otherwise not in accordance with the contract, the contract shall on demand in writing from the P.O. cum D.W.O.,BCW & TD, North 24 Parganas specifying the work materials or articles complained of notwithstanding the same may have been inadvertently passed certified and paid for, forthwith rectify ,or remove and reconstruct the work so specified in whole or in part as the case may be regular or as the work so specified in whole or in part as the case may be regular, or as the case may be removed the materials or article so specified and provide other proper and suitable materials or articles at his own proper charge and cost, and in the event of his failing to do so within a period to be specified by the P.O. cum D.W.O., BCW & TD, North 24 Parganas in his demand afore-said then the contract then the contractor shall be liable to pay compensation the rate of 1 % (one percent) on the amount of the estimate for every day not exceeding 10(ten) days, while his failure to do so shall continue and in the case of such, failure the P.O. cum D.W.O.,BCW & TD, North 24 Parganas may rectify or remove and re-execute the work or remove and replace with others, the materials or articles complained or as the case may be at the risk and expense in all respect of the contractor.

5. Work to be open for inspection and contractor or his responsible person to be present at the time of inspection

All works under or in course of execution or executed in presence of the contractor shall at all times to be open to the inspection and supervision of the P.O. cum D.W.O.,BCW & TD, North 24 Parganas and his subordinates and the contractor shall at all times during the usual working hours and at all other time at which reasonable notice of the intention of the P.O. cum D.W.O.,BCW & TD, North 24 Parganas his subordinate to visit the work shall have been given to the contractor either himself be present to receive orders and instructions or have a responsible event fully accredited in writing present for that purpose, orders given to the contractor's agent be considered to have the same force as if they had been given to the contractor.

6. Contractor is liable for damage done and for imperfection within 12 Months after certificate.


If any imperfection become apparent in it within 12 (twelve) months certificate final or other of its completion shall have been given by P.O. cum D.W.O.,BCW & TD, North 24 Parganas the contractor shall take the same goods at his own expense, or in default the P.O. cum D.W.O.,BCW & TD, North 24 Parganas may cause the same to be made good by workman and deduct the expense (of which the certificate of the P.O. cum D.W.O.,BCW & TD, North 24 Parganas shall be final) from any sums that may be then or at any time therefore may become, due to the contractor, or from his security deposit or there proceeds of sale thereof or a sufficient portion thereof. The security deposit of the contractor shall not be refunded before the expire of twelve Months after the issue of the certificate final or otherwise of completion of work.

When the estimate on which the tender is made include lump sums in respect of parts of the work, the contractor shall be entitled to payment in respect of the items of work involved or the part of the work in question at the same rates as are payable under the contract for such items or if the part of the work in question is not, in the opinion of the P.O. cum D.W.O.,BCW & TD, North 24 Parganas capable of measurement, the P.O. cum D.W.O.,BCW & TD, North 24 Parganas at his direction pay the lump sums amount entered in the estimate and the certificate in writing of the P.O. cum D.W.O. ,BCW & TD, North 24 Parganas be paid final and conclusive against the contractor with regard to any sum or sums payable to him under the provision of this clause.

The decision of the P.O. cum D.W.O., BCW & TD, North 24 Parganas shall be binding, conclusive between the parties or their respective representative with regard to the quality of materials and work provided done by the contractor.

If any extra work be required which cannot be brought within the items of the schedule, the price must be settled and agreed upon in writing before such work is commenced.

All terms and conditions laid down in WBF 2911(i) would be strictly followed in executing the work.
