For preparation of a panel for filling up of vacancy to the post of member of Child Welfare Committee for North 24 Parganas which hold its sittings in multiple places, designated and notified as situation demands. Nominations of qualified candidates (Residing in North 24 Parganas District) are hereby being invited from the public. Final Selection will be made by the Selection Committee constituted for the purpose in terms of Section 23 of West Bengal Juvenile Justice (Care & Protection of Children Rules, 2003). The applicants should have requisite qualifications as mentioned below:-

A) Qualification for Members of the CWC:-

A person to be selected as a Member of Child Welfare Committees should be a respectable well educated citizen shall have at least a graduation in any of the disciplines, preferably in social science in addition to a minimum of seven years experience in their respective field.

B) The Member of the Committee shall be a person not less than 32(thirty two) years of age and not more than 67(sixty seven) years of age.

A member of the Committee shall be eligible for appointment for the maximum of two consecutive terms.

A member of the Committee may resign at any time by giving one month's notice in advance in writing.

C) The appointment of any member of the Committee may be terminated after holding enquiry by the State Government, if

- i) He has been found guilty of misuse of power vested under the Juvenile Justice (Care and Protection of Children) Act 2000;
- ii) He has been convicted of any offence involving moral turpitude and such conviction has not been reversed or he has not been granted full pardon in respect of such offence;
- iii) He fails to attend the proceedings of the Committee for consecutive three months without any valid reason or he fails to attend less than three-fourth of the sittings in a year.

No person shall be considered for Selection as a Member of the committee, if he

- i) Is associated with any adoption agency;
- ii) Has a previous conviction agency;
- iii) Has been involved in any immoral act or in an act of child abuse or employment of child labour;
- iv) Is holding such full time occupation that may not allow him to give necessary time and attention to the work of the Committee as per the act and these rules;

Member of Child Welfare committee shall be paid travel and sitting allowances in accordance with Rule 8 and Rule 23 of the West Bengal Juvenile Justice (Care & Protection of Children) Rules, 2009. Nomination in plain paper along with bio data and self declaration in enclosed format may be submitted on all working days (11 a. m. to 4 p.m. ) within 15 days of publishing this Notice (up to 4.00 p.m. on 17.03.2016. ) to the District Social Welfare Section , North 24 Parganas.
