Sub-Contractual appointment of KTS in World Bank assisted districts under NVBDCP in existing vacancies initially for the period of Six months or upto 31.3.2013 (Which is earlier).

In order to eliminate Kala-azar in the endemic districts of the state to enhance the monitoring and supervision (specially for surveillance, case management & complete treatment), it is decided to engage six Kala-azar Technical Supervisers per district in the endemic districts (in terms of D.O No-3-87/2008-NVBDCP (KA/WB/KT) dated 28.7.2008 and G.O no-HF/O/PHP/244/2 M-04-08 dated 17.06.2009. Considering the short term nature of engagement, it was decided to engage the retired HS(Male)/ HA(Male), and Govt. of India (NVBDCP), Delhi has approved it. Now to fill up the existing vacancy in different districts, it is proposed that

- A) While selection, the eligibility of upper age limit may be 62 (Sixty Two) years.
- B) They may be allowed to work till 65 years, provided they are physically fit to carry out the Job and performance is satisfactory. Thus after completing 62 years, they have to furnish the medical certificate of fitness indicating that they are "physically fit and mentally alert" to carry out the job of KTS including driving motor cycle.

Now you are requested to take necessary steps for contractual appointment of KTS in existing vacancy as per guidelines given below.

- 1) Prepare a list of retired HS(Male) and HA(Male) in your district (age below 62 years as on 1.10.2012)
- Out of the list mentioned in (1) a short list of willing candidate having two wheelers driving licence will be prepared.
- 3) A walk-in interview of the candidates mentioned in (2), will be done and a panel will be prepared by a three member selection Committee- CMOH (Chairman), Representative of District Magistrate and Dy.CMOH-II (Member Secretary). The panel will be valid for six months only.
- 4) The chairman, District Health & FW Samity will engage KTS in the existing vacancy out of the panel mentioned in (3). A contract has to be signed (D.O No.3-87/2008-NVBDCP(KA/WB/KT) dated 28.7.2008. The contract is initially for six months or upto 31.3.2013 (which is earlier).
