Sealed quotations are invited by the Chief Medical Officer of Health, North 24 Parganas from reputed contractors/Govt. order suppliers to supply the following items under National Tuberculosis Elimination Programme:


**Terms & Conditions:**

- The quotations to be submitted in sealed envelope in the drop box kept in the District Tuberculosis Centre, North 24 Parganas located in the campus of North 24 Parganas District Hospital, Barasat. The envelope should be superscripted as "Quotation for Water Purifiers for NTEP" and should contain the name and address of the quotationer.
- The quotationer will have to submit the following documents along with the quotation:
  - Self-attested photocopy of valid GST registration certificate.
  - Self-attested photocopy of valid trade license.
  - Self-attested photocopy of PAN card.
  - Self-attested up to date P. Tax challan.

Quotations received without the above mentioned documents will be summarily rejected.

- The bidder quoting the lowest rate, if all other conditions are satisfied, will be issued "Purchase Order".
- The quoted cost should include all kinds of taxes and duties. It should also include installation charges.*
- The items should be supplied and installed directly at the DTC, North 24 Parganas.
- Items will be delivered and installed free at consignee's end, including freight, forwarding and under standard transit insurance clause that the purchaser will not pay separately for the insurance charges and it will be the contractor's responsibility for the safe arrival of goods in full and good condition.
- Demonstration and installation of the items will be carried out free of cost at consignee's place.
- Items shall conform to on-site warranty for a period of one (01) year from the date of supply and/or installation.*

9. The AOC will be valid for three months from the date of issue.
10. The selected vendor, on receipt of AOC, should submit A/C payee Demand Draft of 10% of the contract value in favour of Secretary, DH & FW Samiti, North 24 Parganas within 03 working days of receipt of AOC. Purchase Order will be issued only after submission of Demand Draft as specified above. After successful completion of the work, the Demand Draft will be returned to the vendor. If the vendor fails to submit the Demand Draft within the stipulated time, the AOC will be rejected without any further information to the concerned vendor.
11. The items should be supplied within 7 (seven) days of receipt of purchase order.
12. If the lowest quotationer fails to supply the items within the stipulated time, the 'Purchase Order' will deemed to be cancelled.
13. Payment will be made only after supplying and installation of all the items in the 'Purchase Order' and after receipt of a 'satisfactory supply and installation certificate' from the District Programme Co-ordinator of NTEP. Partial supply of items within the stipulated time will be considered as non-supply and, in such case, the 'Purchase Order' will deemed to be cancelled.
14. Detailed information may be obtained from the Office of the DTO from 26/02/2021 to 04/03/2021 on working days between 11 AM to 2 PM.
15. All payments will be made in account payee cheque/direct bank transfer only. Deductions will be made from the final bill as per existing Govt. rules and regulations.
16. The participants in the quotation process may remain present personally or may send an authorized representative during opening of quotations.
17. If after opening of quotations or at a later stage it is found that the items do not conform to the specifications, the quotation/purchase order will be summarily rejected and no payment will be made in such cases. If such discrepancies are noted after payment, the vendor/supplier will be bound to return the full amount within 07 (seven) days of cancellation of the purchase order.
18. Submission of quotation will imply that the quotationer will abide by all the terms and conditions mentioned in this 'Notice Inviting Quotations'.
19. In case of any dispute, decision of the Purchase Committee, Office of the CMOH, North 24 Parganas will be final and bounding to all.
20. The Purchase Committee, Office of the CMOH, North 24 Parganas reserves the right to cancel/change/modify this notice completely or partially without giving any notice to anybody.
