Sealed quotations are hereby invited from reputed, interested and bonafide Data Entry Agencies for filling up the online form in the Swasthyasathi portal, i.e., http://swasthyasathi.wbhealth.gov.in for each eligible Swasthyasathi beneficiary of North 24 Parganas district and her/his family members as mentioned in Format-B form, which are submitted to District Swasthyasathi cell in the office of the District Magistrate, North 24 Parganas.

SL NO.	TECHNICAL REQUIREMENT
1	Minimum Three (3) years of existence as a registered firm engaged in data entry work in Population Census, Agriculture Census and Parliament/Assembly/Panchayat Elections in the last four financial years. (Relevant Work Order in this respect should be provided)
2	Minimum Twenty (20) working computers running under Windows 7 or Higher Operating System with Internet Connectivity in every computer .
3	Trained data entry operators must have minimum data enrty speed of 10 records per hour.

ELIGIBILITY CRITERIA:

- 1. The Organization Bidding should be a single Agency. No Consortium bodies are eligible to bid. The Agency shall not outsource the work to any other Associate/Franchisee/Third Party under any circumstances.
- 2. The Bidder (Single agency) must be incorporated or registered in India under the Indian Companies Act, 1956 OR the Partnership Act, 1932 OR Societies Registration Act 1860 OR the Indian Trusts Act 1882/its equivalent in the respective states OR Proprietorship entities having a PAN of the Income-tax department, Govt of India.
- 3. The Bidder (single agency) should not have been blacklisted by the Central, any State/UT Government, or any central or state Government agency as on the date of issue of this Tender Document or during the subsequent bid processing and evaluation.
- 4. Schedules would be released shortly for Data Entry. The Agency would be expected to upload at least 2,000 beneficiary data per day in the online database.
- 5. The agency will be responsible for the security, safe-custody and confidentiality of the documents provided to them for data entry during the period the documents remain in their custody.

- 1. The Agency should apply in company's own letterhead.

- 4. Incomplete or incorrect quotations will be summarily rejected.
- 5. The competent authority reserves the right to reject any/all quotations without assigning any reason thereof.
- 6. The data entry should be started on and from the date provided to them by the undersigned. It should be ensured to complete the task in the stipulated time frame..

The maximum rate of data entry is Rs.2.00 only per beneficiary inclusive of family members as per Memo no:HF/O/SS/DIST-FUND/3740 dated 31-01-2017 of Department of Health and Family Welfare, Swasthya Bhaban, Kolkata-700091. The payment shall be made after satisfactory completion of the job. The Agency must submit the bills in duplicate.
