

GOVERNMENT OF WEST BENGAL OFFICE OF THE DISTRICT MAGISTRATE NORTH 24 PARGANAS (JUDICIAL MUNSHIKHANA DEPARTMENT)

Order

Whereas Authorized Officer, UCO Bank, Titagarh Branch, 13 B.T Road, Titagarh, North 24 Parganas, PIN – 700 119 applied before the District Magistrate, North 24 Parganas has filed a petition to the District Magistrate, North 24-Parganas, u/s 14 of SARFAESI Act of 2002 seeking administrative assistance for taking physical possession on the secured Asset / Property of the Borrower namely Tapan Kumar Das S/o Kartick Chandra Das and Alpana Das W/o Tapan Kumar Das; both residing at 61/370 Sukanta Nagar P.O. Panshila, P.S. Khardah, North 24 Parganas, PIN – 700 112; in the Case No.: 857 / 22 dated 27 / 09 / 2022.

And

Whereas in the light of above matter the petition along with affidavits and other relevant documents submitted by the Authorised officer UCO Bank, Titagarh Branch, 13 B.T Road, Titagarh, North 24 Parganas, PIN – 700 119 applied before the District Magistrate, North 24 Parganas seeking administrative assistance in terms of Section 14 (1) of the SARFAESI Act of 2002 for taking over physical possession of the Secured Asset is seen and taken up for consideration.

And

Whereas from the documents and status report submitted by the Authorised Officer, it transpires that secured creditor granted loan of Rs. 17,50,000.00 (Rupees Seventeen Lakhs Fifty Thousand) only on 17/10/2015 to the Borrower viz. Tapan Kumar Das S/o Kartick Chandra Das and Alpana Das W/o Mr. Tapan Kumar Das against the mortgaged piece and parcel of landed property as follows:

- All that piece and parcel of land measuring 02 Cottahs 02 Chittacks 13 Sq.Ft. of land with 2 storied Dwelling House Measuring 1624 Sq.Ft. (At ground floor) admesuring 742 Sq.Ft., 1st floor admeasuring 742 Sq.Ft. along with mezzanine floor area 140Sq.Ft. which is lying and situated at Mouza- Bandipur, J.L No.-14, R.S No.-90, Touzi No.-1514, 181,172 and 1512, R.S Khatian No.-1108 and L.R Khatian-2964, R.S and L.R Dag No.-1758 Nature of land Bastu Holding No.61/370, Sukanta Nagar Ward No.-6 under Khardah Municipality, P.S- Khardah, Deed No. 152405322 in the year 2015 registered at ADSR Sodepur, North 24 Parganas.
 - The Mortgaged Property stands in the name of Tapan Kumar Das.

 The property is butted & bounded by: North 11Ft. wide municipal road, South 10 ft. wide municipal road, East House of Sudhangshu Dutta & West House of Dolly Roy.
- 2) The borrower has committed default in repayment of the financial assistance granted aggregating the specified amount and consequent to such default in repayment, the account of borrower was classified as NPA on 30/04/2022 due to non-servicing of interest/ installment.
- 3) Notice dated 22/06/2022 u/s 13(2) of SARFAESI Act. 2002 demanding payment of default amount was served to the defaulting borrower. The outstanding amount as mentioned in notice is Rs. 12,42,177.00 (Twelve Lakhs Forty-Two Thousand One Hundred Seventy-Seven) only. The demand notice was delivered on 29/06/2022 by hand.
- 4) The Authorised Officer of the Secured Creditor received no representation from the borrower in reply to demand notice u/s 13(2) dated 22/06/2022
- 5) The Secured Creditor issued possession notice dated 30/08/2022 u/s 13(4) of SARFAESI Act of 2002 for taking Possession on the secured assets of the borrower and also published the same in the daily newspapers on 01/09/2022.
- Thus the Authorised Officer of the Secured Creditor observed all the formalities as laid down in the SARFAESI Act 2002 for realization of the said outstanding amount from the Secured Debtor And
 - Whereas, the Secured Asset is within the jurisdiction of the District Magistrate, North 24 Parganas.

And

8) Whereas, the amount dues is more than 20% of the Principal Advance and Security Interest is not created in any agricultural land

And

9) Whereas, the Secured Creditor wants to reconstruct their financial asset(s) after handing over and taking over physical possession of the Secured Asset / Property as scheduled above, belonging to the Borrower(s) / Co-borrower(s) / Director(s) / Guarantor(s) / Partner(s) / Proprietor(s) / Corporate Guarantor(s) / Surety(s) as per law in force

Whereas, for the purpose of taking possession of the Secured Asset(s) and documents, the Secured Creditor requested the District Magistrate, North 24 Parganas u/s 14 of SARFAESI Act, 2002.

And

11) There is no case pending before any court of law under Section 34 of SARFAESI Act, 2002 in this regard filed by the borrower as per '30 Clauses' declaration submitted by the Secured Creditor and as per affidavit dated 26/09/2022 submitted by the Secured Creditor there is no stay declared by any court of law.

And

12) The property is not under lessee / tenancy as per affidavit, deed(s), records or all other relevant documents

And

Therefore, after careful consideration of the contents of the affidavit including the nine clauses mentioned under Section 14(1) B of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 and all other relevant documents, which the Secured Creditor filed duly affirmed by the Authorized Officer of UCO Bank, Titagarh Branch, 13 B.T Road, Titagarh, North 24 Parganas, PIN – 700 119 applied before the District Magistrate, North 24 Parganas and being satisfied, it is hereby ordered that Sri Kuntal Bose, Executive Magistrate by Sub Section (1) of Section 20 of the Criminal Procedure, 1973 (Act 2 of 1974) in the Office of the Sub - Divisional Officer, Barrackpore, under the District Magistrate, North 24 Parganas will take physical possession of the Secured Asset(s) / Property(s) and forward the same to the Secured Creditor u/s 14 (1A) of SARFAESI Act, 2002.

And

Whereas, Authorized Officer of UCO Bank, Titagarh Branch, 13 B.T Road, Titagarh, North 24 Parganas, PIN – 700 119 applied before the District Magistrate, North 24 Parganas shall intimate the date of possession of the Secured Asset to the Commissioner of Police, Barrackpore Police Commissionerate, North 24 Parganas as well as to, Sri Kuntal Bose, Executive Magistrate by Sub Section (1) of Section 20 of the Criminal Procedure, 1973 (Act 2 of 1974) in the Office of the Sub - Divisional Officer, Barrackpore under the District Magistrate, North 24 Parganas, well in advance to take physical possession of the Secured Asset(s) / Property(s) of the Secured Creditor on behalf of District Magistrate, North 24 Parganas. The Commissioner of Police, Barrackpore Police Commissionerate, North 24 Parganas will provide Police Force for maintenance of Law & Order. The Secured Creditor will remain present at the time of taking over physical possession.

A spot videography should be made in connection with taking over physical possession of Secured Asset(s) / Property, on the date of taking over possession and soft copy of the videography should be kept under custody.

Let copy of this order be served upon all concerned.

The order is to be enforced within 06 (Six) months from the date of receipt of this order.
